(4) Off Premise cash (50/50) Raffle fee is \$20.00 to the State and \$20.00 to the Borough with submission of application. If more than \$1,000 is awarded in prizes, then additional \$20.00 to the State and \$20.00 to the Borough per each \$1,000 in awarded prizes or part thereof.

(5) Special Door Prize Raffle no fee and no license required provided the merchandise is wholly donated and has a retail value of less than \$50.00 and provided that other games of chance are not being conducted, held or operated.
