Parents are required to complete on behalf of children under the age of 18 years

All Adult Members are required to sign individually

PLEASE take the time to read through this paperwork and complete as directed

- Each Family Member will be required to complete **one** Waiver and Consent, **one** Code of Conduct Form and the Watercraft waiver (members over age 13) as part of the Registration Packet;
- ALL Members: Proof of Residency is REQUIRED to be eligible for In-Town Registration Rates (current license, utility bill, etc.);
- All Family Members must be listed on each form, and children will require an adult's signature (see below*);
- Multiple Families at the same address are required to complete a separate Registration, Waiver and Consent/Code of Conduct Form;
- **Adults/Members Age 18/Over:** Waiver and Consent/Code of Conduct must be signed on your own behalf (an adult cannot sign for another adult, unless you are that adult's legal guardian).
- ***Children/Members Age 18/Under:** A Parent/Guardian must sign the Waiver and Consent/Code of Conduct, on behalf of **every** Child under the age of 18 years old.
- All Children under the age of 16 must be accompanied by an adult/guardian (per revised N.J.A.C. 8:26-5.1(a)2.(d)1)

Waiver & Consent: I acknowledge that I am or my child is in suitable physical condition to participate in the recreation program, activity, sport, trip or event that I have registered for or have registered my child for & I hereby assume any risks involved by such participation. I certify that I am or my child is fully capable of participating in this recreational program, activity, sport, trip or event & that I do not have or my child does not have any physical or mental disability that would restrict full participation. For me & on behalf of my child, I do hereby waive, release, indemnify & hold harmless the Borough of Lincoln Park, its directors, superintendents, employees & volunteers from any liability &/or for any injury or damages that may be suffered by me or my child in the course of participation in the recreation program, activity, sport, trip or event & the activities incidental thereto, whether the result of any negligence or any other cause. In the event I am unable or unavailable to do so, I grant permission to receive or have my child receive emergency professional medical care as deemed necessary by the Recreation Staff. I agree to abide by the Rules & Regulations of the Lincoln Park Recreation Dept. & those of the venue that the Lincoln Park Recreation Dept. is visiting.

Photo Waiver Acknowledgement: Lincoln Park Recreation reserves the right to photograph attendees throughout the course of their events. As an attendee &/or on behalf of my child, I hereby grant permission to the Borough of Lincoln Park, its directors, superintendents, employees & volunteers to photograph me &/or my child & use the images solely for public relations purposes &/or the social media pages of the Borough of Lincoln Park. I do hereby waive, release, indemnify & hold harmless the Borough of Lincoln Park, its directors, superintendents, employees & volunteers from any liability &/or for any injury or damages that may be suffered by me or my child as a result of the taking or use of the photograph & images obtained in the course of participation in the recreation program, activity, sport, trip or event & the activities incidental thereto, whether the result of any negligence or any other cause.

The Recreation Department advocates and supports membership programs in Lincoln Park. The Borough proudly offers membership with the Lincoln Park Community Lake. Membership is subject to the observance of rules and procedures. The activities outlined below are **strictly prohibited**. Any participants, volunteers or staff members who violate this code are subject to discipline, up to and including removal from the program.

- Abusive language towards a staff member, volunteer, or other participant.
- Discourtesy or rudeness to a fellow participant, staff member, or volunteer.
- Verbal, physical, or visual harassment of another participant, staff member, or volunteer.
- Bullying or taking unfair advantage of any participant.
- Failure to cooperate with adult supervisor/leader/mentor.
- Possession or usage of alcoholic beverages or illegal drugs on the Borough of Lincoln Park property or reporting to the program while under the influence of drugs or alcohol.
- Possession of dangerous or unauthorized materials such as firearms, weapons, or other similar items on Borough property.
- Conduct endangering the life, safety, health or well-being of others.
- Failure to leave area in the condition in which you found it, including restrooms, gym, hallways, and any other area used. Defacing or destruction of any Borough property regardless of condition or value.
- Failure to follow any Department of Recreation policy & procedures.

I have read and understand the Department of Recreation's Code of Conduct. I agree to abide by the rules described above and understand that I may be removed as a participant, volunteer, or staff member if I violate any of these rules.

___ I understand members and guests must be at least 13 years of age to use a kayak or peddle boat, Children under the age of 13 MUST be accompanied by an adult over the age of 18;

___ I understand members and guests must be at least 16 years of age to use a Stand Up Paddleboard;

___ I understand my watercraft must be visible to LPCL Staff at all times and will not go beyond the designated barrier;

___ I understand I/my child must wear my lifevest at all times;

___ I agree to remain on the watercraft at all times;

___ I understand smoking/vaping and/or consumption of alcoholic beverages is prohibited on all vessels

Failure to comply with these guidelines may result in suspension from use of watercrafts and/or loss of membership with no refund.
